I understand that the risk of becoming exposed to or infected by COVID-19 at the roadway clean up may result from actions, omissions, or negligence of myself and others, including, but not limited to, the Clean Communities Council, the County of Salem and its Freeholders; Salem County Improvement Authority, its members, directors, officers, employees, and program directors; volunteers; program participants; and program participants' families.

On my behalf, and on behalf of my children, I hereby RELEASE, COVENANT NOT TO SUE, DISCHARGE, INDEMNIFY AND HOLD HARMLESS the Clean Communities Council, the County of Salem and its Freeholders, and the Salem County Improvement Authority, its employees, agents, and representatives of and from the claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this Waiver includes any claims based on the actions, omissions, and/or negligence of the Clean Communities Council, the County of Salem and its Freeholders, and the Salem County Improvement Authority, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in a roadway clean up.
